

BUMAC Database License Agreement

Dear Visitor,

BEFORE YOU SIGN AND SUBMIT THIS LICENSE AGREEMENT, PLEASE READ CAREFULLY THE TERMS AND CONDITIONS BELOW. BY SIGNING AND SUBMITTING THIS DOCUMENT YOU ARE CONSENTING TO BE BOUND BY AND ARE REQUESTING TO BECOME THE LICENSEE OF THE DATABASE. IF YOU DO NOT AGREE WITH ALL OF THE TERMS OF THIS LICENSE, PLEASE DO NOT SIGN AND SUBMIT THIS DOCUMENT.

This End-User License Agreement is a legally binding contract between you ("You") and the University of Western Macedonia (UOWM) which is the BUMAC Database operator ("operator").

TERMS & CONDITIONS OF USE OF THE BUMAC DATABASE ("Database")

The following terms and conditions govern your access to and use of the Database:

When you sign and submit the License Agreement, the operator will examine your request to be granted a license for the use of Database. The operator will then notify you electronically of its decision to grant you a license, of your access rights and of the procedure to obtain information of the Database. The Database contains technical data and information made available by the operator. This data and information is made available on an AS IS, WHERE IS basis and the operator makes no warranty whatsoever, and specifically disclaims any warranty of merchantability or fitness for a particular use.

Upon favourable examination of your request you ("Licensee") will be granted a non-exclusive, non-transferable license for the Database. The license permits to the Licensee to use the Database as defined in the Section below in accordance with the terms contained in this Agreement.

In this Agreement "Use" shall mean and include the utilisation of the Database by accessing its contents via the BUMAC database web server internet address that shall be provided to the licensees.

Subject to all the terms of this license, the operator grants you a limited, non-exclusive, personal, non-sublicensable, non-assignable license to use the BUMAC Database.

Subject to the provisions contained herein, the operator hereby grants the Licensee a License to use the Database free of charge for research and educational purposes. You, in the capacity of a Licensee, are **NOT** permitted to copy or redistribute the Database in any form without the express written permission of the operator. You are permitted to use the Database freely, provided that you:

- Make available to the operator for its internal purposes any reports and documents produced and/ or developed with the BUMAC database which would enable the operator to further improve the BUMAC database;
- Duly reference the BUMAC Database in all and any reports produced by the Licensee with the use of BUMAC;
- Shall only make fair use of the BUMAC server resources;
- Not to disassemble, decompile or reverse engineer BUMAC by manner (or to attempt to perform such action or have such actions performed by third parties);
- Not to sub- license, provide or otherwise make available BUMAC database to any person than your employees or as specified herein without prior written consent from the operator;
- Not to display the BUMAC database on a public bulletin board, ftp site, worldwide web site, chat room or by any other unauthorised means;
- Not Use any part of the BUMAC database for the purpose of creating any rival / competitive product to BUMAC;
- Not to Use the BUMAC database for immoral, illegal or for any other purpose which may be determined threatening, abusive or harmful including but not limited to the creation or transmission of any viruses, worms, Trojan horse, cancelbot or any other destructive or contaminating programme;
- Not to sell and or commercialise the BUMAC database.
